AS THE 'LEGAL CAPITAL OF THE WORLD', THE CITY OF THE HAGUE IS WELCOMING AN INCREASING NUMBER OF INTERNATIONAL COURTS, TRIBUNALS AND INSTITUTIONS. THIS DEVELOPMENT REFLECTS THE GROWING IMPORTANCE NATIONS AND COMMUNITIES ATTACH TO INTERNATIONAL CRIMINAL JUSTICE.

THE GLOBAL FIGHT AGAINST IMPUNITY FOR CORE INTERNATIONAL CRIMES IS ALREADY SHAPING INTERNATIONAL RELATIONS BETWEEN GOVERNMENTS, COURTS, AND ORGANISATIONS. DIPLOMATS ARE REGULARLY FACED WITH A WIDE RANGE OF ISSUES RELATED TO INTERNATIONAL JUSTICE AND ARE EXPECTED TO INCREASINGLY BE INVOLVED WITH IT IN THE FUTURE.

WITHOUT A SPECIALIZED BACKGROUND, HOWEVER, IT IS A CHALLENGING TASK TO KEEP TRACK OF THE DEVELOPMENTS, TO UNDERSTAND THE CONCEPTS, THE PRACTICAL IMPLICATIONS FOR GOVERNMENTS, AND THE DILEMMAS THE INTERNATIONAL CRIMINAL COURTS AND TRIBUNALS ARE FACING.

FOR THIS REASON, THE VU UNIVERSITY CENTER FOR INTERNATIONAL CRIMINAL JUSTICE (CICJ) OFFERS A TWO-DAY WORKSHOP "UNDERSTANDING INTERNATIONAL CRIMINAL JUSTICE" SPECIALLY TAILORED TO THE NEEDS OF DIPLOMATS WHO HAVE LIMITED KNOWLEDGE OF THESE TOPICS, AND WOULD LIKE TO GAIN A MORE THOROUGH UNDERSTANDING OF THE INCREASING ROLE OF INTERNATIONAL CRIMINAL JUSTICE IN TODAY'S WORLD.

THE PRESENTERS - EXPERTS IN INTERNATIONAL CRIMINAL LAW, CRIMINOLOGY, AND COURT-REPORTING - WILL ENSURE THAT THE PROGRAMME SERVES AS A PRACTICAL AND BROAD INTRODUCTION INTO THE FUNCTIONING OF INTERNATIONAL CRIMINAL JUSTICE.
